




#### **Hong Kong Employment Visas**

" Does the applicant possess a special skill, knowledge or experience which are of value to and not readily available in Hong Kong?"

Moreover, the Immigration Department will:

" .... take into consideration, amongst other things, whether it is justified for the employer to bring in an expatriate staff. "



applicant to have something special about them

C/w others, local and expat alike

which relates to a skill, knowledge or experience

In the context of the job offer in hand

that something 'special' should be of value to Hong Kong

Economic, social, educational and the like...

and not easily found within the local workforce

Without the need to expressly and in every case prove the impossibility of identifying similar talent locally








## Even if the above limbs of the test are satisfied, should a local Hong Kong person be employed to do this job?

- should the employer be training a local person to do this job?
- or, by paying more to a local than the prevailing rate, will the job be easily filled by a suitably qualified local Hong Kong person attracted by the higher remuneration available?

#### MAKE SURE YOU IDENTIFY YOUR OWN TYPE & PREPARE PROPERLY

#### Intra-company Transferee

No strident argument usually required



### **Specifically Recruited Expat from Overseas**

Unless a very serious appointment, strident argument a MUST

#### Locally Recruited Expat

Strident argument almost always required



**Three Types of Applicant** 




#### **Sponsorship**

ID990B seeks to satisfy the 'justified' limb of the Approvability Test



If the business is new, it too will be 'tested' as a suitable & credible sponsor

Change of status from visitor to employment is possible

#### **Changing Employer**

Unapproved employment is illegal employment

Legal spouse
Dependant children
Unmarried partner

#### Why Do Applications Get Denied?



Case fatally flawed from the outset

- 1. Not Professional
- 2. Compensation too little
- 3. Skills available locally
- 4. Related prior denials or poor history

Poor preparation and approvability analysis

Insufficient supporting documentation


Requests of the HKID not afforded the requisite level of importance



Your 'Reconsideration' application to be based upon:

"New and Previously Unsubmitted Information"

- No emotional appeals
- No mere rehash of the original argument
- No shuffling of the first set of papers



**Trying Again?** 

A solid Reconsideration application requires:

- Significant additional new information adding weight to the original application and/or
- Relevant and important new facts which have come to light since the refusal
- Comprehensive verifying documentation in support

If case has merit, the Process takes between 6 and 16 weeks – if not, usually 10 days to 2 weeks






